We are closing out the Fall 2023 semester featuring MSE DEI Committee member Itzel Esparza (she/her/hers), who recently presented her work at the Lehigh MSE Undergraduate Research Symposium last month! Itzel presented her work focused on designing and creating a synthesis apparatus for the growth of larger Cu-BTC crystals. The apparatus will feature a corrosioncompatible autoclave that will withstand the acids essential for Cu-BTC growth, offering a controlled environment for precise pressure and temperature adjustments. The aim is to achieve larger crystals through this controlled growth, which will represent a critical advancement with implications for clean energy storage, efficient gas separation, and sustainable catalysis.
